An oil spill caused by a sunken cargo ship in the Sea of Japan was almost cleaned up on Thursday evening, preventing the slick from reaching coastal areas.

The oil apparently leaked from a cargo ship that collided with a fishing boat early on Sunday. The foreign cargo vessel, with 18 crew members aboard, collided with the Japanese fishing boat, carrying 8 crew members, and sank to a depth of 170 meters about 26 km southeast of the Oki Islands. It was carrying about 98.5 tons of fuel oil.

Earlier on Thursday, Japan Coast Guard officials said the slick was about 14 km off the northern coast of Hyogo Prefecture. The slick was about 9 km long and located off the coast of Hamasaka, Hyogo Prefecture.

Vessels from the coast guard, transport ministry, local fishing cooperative and Self Defense Forces were mobilized to recover the oil and prevent the slick from spreading.

The crew of the cargo ship were taken aboard the fishing boat. No one was injured seriously in the collision but two crew members of the fishing boat received minor injuries.
